2.3. Other hazards

Use of this product is not normally considered hazardous, however material dust caused by cutting, sawing or sanding may cause eye or skin irritation. Processing at temperatures higher than 300°C can cause the evolution of particulate matter which can cause “polymer fume fever” which is a temporary condition that can cause flu-like symptoms and eye and respiratory irritation. The smoking of tobacco contaminated with PTFE can cause this condition. Processing at temperatures higher than 400°C will result in thermal decomposition of fluorinated thermoplastics and may release carbonyl fluoride which hydrolyses to hydrogen fluoride and carbon dioxide by reacting with moisture in the air, and silicon dioxide may also be released. In all cases avoid exposure, move the individual to fresh air and consult a physician if severe.

Symptoms:	Local irritation. The thermal decomposition vapours of fluorinated polymers may cause polymer fume fever with flu-like symptoms in humans, especially when smoking contaminated tobacco. Symptoms may be delayed. Repeated episodes of polymer fume fever may result in persistent lung effects. Inhalation of decomposition products from overheating may cause lung irritation or shortness of breath. For inter-liner, after inhalation of decomposed products, nuisance fumes and dust can be irritating to the upper respiratory tract.
